The table below shows all share classes currently available for each fund along with their fees. Class suffixes

Letter and number codes Certain letters and numbers in share class labels have particular meanings:

- **Currency codes** Each share class carries the standard three-letter code for the currency in which it is denominated.
- **Cap, Dis** “Cap” indicates accumulating shares; “Dis” indicates distributing shares.
- **(Hedged)** This indicates shares that use hedging to seek to cancel out most of the effect of exchange rate fluctuations between the share class currency and the fund’s base currency. Note that shareholders are still exposed to any other currencies to the extent that a fund

has such exposures. Currently all classes are hedged in this way. Hedging is unlikely to eliminate 100% of the differences it seeks to hedge.

- **Perf** These share classes charge a performance fee.

Fees Any purchase, exchange, conversion, or sale may involve fees. If you are investing through an intermediary, a portion of any entry fees paid may go to that intermediary. No sale fees (or redemption fees) are charged when selling shares. No funds or share classes carry any contingent deferred sales charges.
